## ANNUAL REPORT Under California Education Code 15280(b)

June 20, 2023

#### I. Introduction

Petaluma City Schools were successful in obtaining authorization from the District's voters to issue general obligation bonds through a local election on June 3, 2014, for both Petaluma City (Elementary) School District and the Petaluma Joint Union High School District. The Elementary School District obtained authorization to issue up to \$21,000,000 in aggregate principal amount of general obligation bonds pursuant to Measure E. The High School District obtained authorization to issue up to \$68,000,000 in aggregate principal amount of general obligation bonds pursuant to Measure C. The Bond Elections were conducted under Proposition 39, being chaptered as the Strict Accountability in Local School Construction Bonds Act of 2000, at Section 15264 *et seq.* of the Education Code of the State ("Prop 39").

The Citizens' Oversight Committee of Petaluma City Schools District (the "COC") was formed pursuant to Measures E and C for the purpose of actively reviewing and reporting on the expenditure of Measure E and C bond proceeds. The COC is required to advise the public, through at least one report per year which shall be made available on the District's web site, as to whether the District is in compliance with Article XIIIA of the California Constitution, Measure E and C, and the provisions of Education Code Section 15278 and following.

#### A. Section 1 of Article XIIIA of the California Constitution

Section 1(b)(3) of Article XIIIA of the California Constitution provides that bonded indebtedness incurred by a school district for the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities include certain accountability requirements:

(A) That the proceeds from the sale of the bonds be used only for the purposes specified in Article XIIIA, Section 1(b)(3), and not for any other purpose, including teacher and administrator salaries and other school operating expenses.

- (B) The proposition shall contain a list of the specific school facilities projects to be funded and certification that the school district board has evaluated safety, class size reduction, and information technology needs in developing that list.
- (C)A requirement that the school district board conduct an annual, independent performance audit to ensure that the funds have been expended only on the specific projects list.
- (D)A requirement that the school district board conduct an annual, independent financial audit of the proceeds from the sale of the bonds until all of those proceeds have been expended for the school facilities projects.

#### B. The Citizens Oversight Committee; Purpose and Activities

California Education Code §15278(a) provides that if a bond measure authorized pursuant to paragraph (3) of subdivision (b) of Section 1 of Article XIIIA of the California Constitution and subdivision (b) of Section 18 of Article XVI of the California Constitution is approved, the governing board of the school district establish and appoint members to an independent citizens' oversight committee. Section 15278(b) provides that the purpose of the citizens' oversight committee is to be:

- 1. Inform the public concerning the expenditure of bond revenues, and
- 2. Actively review and report on the proper expenditure of taxpayers' money for school construction.
- 3. Advise the public as to whether a school district is in compliance with the requirements of paragraph (3) of subdivision (b) of Section 1 of Article XIIIA of the California Constitution.

Section 15278(b) provides that function of the committee shall be to ensure that bond revenues are properly expended and that no funds are used for teacher or administrative salaries, or other school operating expenses.

#### II. Specific School Facilities Projects Funded by Measures C and E

Section 1(b) (3) of Article XIIIA of the California Constitution requires that in order to incur bonded indebtedness for the construction, reconstruction, rehabilitation, or replacement of school facilities, the proposition presented to voters shall identify the specific school facilities projects to be funded and certify that the school district board has evaluated safety, class size reduction, and information technology needs in developing that list.

#### VI. Sale of Bonds

In June 2022, the Board of Education adopted 2 resolutions:

The first Resolution 2122-36, authorizing the issuance and sale of General Obligation

Bonds, Election of 2014, Series C, in the aggregate principal amount of not to exceed \$5,000,000, and approving related documents and actions for Petaluma City (Elementary) School District.

The second Resolution 2122-37, authorizing the issuance and sale of General Obligation Bond, Election of 2014, Series C, in the aggregate principal amount of not to exceed \$25,000,000, and approving related documents and actions for Petaluma Joint Union High School District.

The Series C Bonds for both Districts were successfully issued on August 3, 2022.

#### VIII. Activities of the Citizens Oversight Committee for Measures C and E

In accordance with Education Code Section 15280(b), the following report is presented to the Board of Education for Petaluma City Schools in the fulfillment of the Committee's annual reporting requirement.

#### A. Activities of the Committee and Summary of Meetings

The Committee met twice between July 2021 and February 2022 and twice between March 2023 and June 2023. The meetings were noticed per the Brown Act and open to the public. Complete minutes are on file at the District Office. District personnel provided staff to the Committee and were present at the meeting.

Review of Expenditures. The COC was provided with expenditure reports prepared by the District at each of it meetings. At each meeting, the COC reviewed the text of Measures E and C and the expenditure reports. Members of the COC had the opportunity to ask District personnel questions regarding the projects and expenditures.

Review of District Bond Audits. With respect to the bond audit for the prior fiscal year, the COC met on March 16, 2023 to review the District's Financial and Performance Audits for the year ending June 30, 2022. The Petaluma City Schools District retained the services of the accounting firm of Nigro & Nigro, A Professional Accountancy Corporation to conduct an independent audit of the revenues,

expenditures, and changes in fund balance related to construction costs for Measures E and C funds as of June 30, 2022.

#### IX. Conclusion

Based on the foregoing review of expenditures and other activities, the COC concludes that bond proceeds spent to date have only been spent for the construction, reconstruction, rehabilitation, or replacement of school facilities, including furnishing and equipping of school facilities, or acquisition or lease of real property for school facilities, as identified in the project list presented to District voters, and as a result the District has complied with California Constitution Article XIIIA Section (1)(b)(3), the text of Measures E and C and Education Code 15278 and following. Furthermore, no proceeds were spent on teacher salaries, administrative salaries or on operational expenses.
